

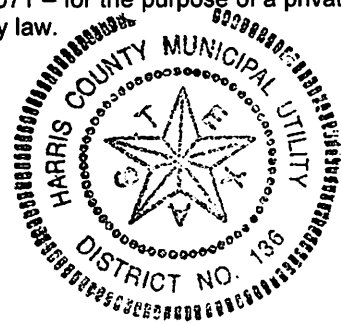


NOTICE

At such meeting, the Board will consider the following:
