**NOTICE**

In accordance with Chapter 551, Texas Government Code and Section 49.063, Texas Water Code, both as amended, take notice that the Board of Directors of Harris County Municipal Utility District No. 136 will meet in regular session, open to the public, at the Deerfield Village Community Association, 4045 Deerfield Village Drive, Houston, Harris County, Texas, 77084, at 6:00 p.m. on Thursday, April 14, 2022. At such meeting, the Board will consider the following:

1. Public comments.
2. Approve minutes of the meeting of March 10, 2022.
3. Update from Acclaim on Public Utility Commission of Texas decisions regarding grid reliability, introduction of Acclaim Reliability Advantage and authorize appropriate action.
4. Review Bookkeeper's Report, investment report, and authorize payment of bills.
5. Review Tax Assessor and Collectors Report, and authorize payment of bills.
6. Review Engineer's Report, Water Plant walk through, Jackrabbit Road Public Utility District matters, Pine Forest Country Club matters, Asset Management Plan, and take appropriate action on engineer's recommendations.
7. Discuss repair and contract for 18-inch gravity line and take any necessary action.
8. Discuss Jackrabbit Road Public Utility District matters and take appropriate action.
9. Review Operations Report, authorize repairs and termination of services to delinquent accounts.
10. Discuss patio homes drainage and settlement issue and fence replacement and take any necessary action.
11. Report on WHCRWA monthly meeting, and related service and construction issues, including WHCRWA installation of an 84" water line through the District.
12. Discuss subcommittee to review consultant contracts and take necessary action;
13. Review trash and recycling operation.
14. Discuss Fall 2022 Shredding and E-cycling event, and also discuss adding a household hazardous waste collection event.
15. Discuss District website and text message notification system and take any necessary action.
16. Review Article for DVCA Newsletter.
17. Review agenda items for next meeting (May 12, 2022) and such other matters as may properly come before the Board.
