**NOTICE**

In accordance with Chapter 551, Texas Government Code and Section 49.063, Texas Water Code, both as amended, take notice that the Board of Directors of Harris County Municipal Utility District No. 136 will meet in regular session, open to the public, at the Deerfield Village Community Association, 4045 Deerfield Village Drive, Houston, Harris County, Texas, 77084, at 6:00 p.m. on Thursday, March 14, 2024. At such meeting, the Board will consider the following:

2. Approve minutes of the meeting of February 8, 2024.
3. Review Bookkeeper's Report, investment report, and authorize payment of bills.
4. Adopt budget for fiscal year ending March 31, 2025.
5. Review Tax Assessor and Collectors Report, and authorize payment of bills.
6. Review Engineer's Report, Water Plant walk through, Jackrabbit Road Public Utility District matters, Out-of-District reviews, Asset Management Plan, and take appropriate action on engineer's recommendations.
7. Discuss emergency interconnect request with Rolling Creek Municipal Utility District.
8. Discuss Jackrabbit Road Public Utility District matters and take appropriate action.
9. Review Operations Report, authorize repairs and termination of services to delinquent accounts.
10. Report on WHCRWA monthly meeting, and related service and construction issues, including WHCRWA installation of an 84" water line through the District.
11. Review trash and recycling operations including consideration of pricing adjustment or contract amendment and take any necessary action.
12. Review Rate Order and take any necessary action.
13. Discuss District website and text message notification system and take any necessary action.
14. Review Article for DVCA Newsletter.
15. Review agenda items for next meeting (April 11, 2024) and such other matters as may properly come before the Board.
